*Shirley Smith--It's Perfectly Normal* is a wonderful, informative book for children of an appropriate age; the only reason to object is to promote ignorance. The public library has a mission; the people who are challenging books are against this goal. They are furious and narrow minded. Librarians are professionals and heroes for standing up to these individuals. The board needs to stand up to them also.

*Jackie Barnes*--My child was sexually abused. This book is similar but in a visual form. Sexual abuse is terrible and requires years of therapy. (Jackie also submitted a handout for the board.) Also, where are the bylaws? I would like to see them.

#### 1. Discussion/Action on 2023 Budget

Brittany and Jenny presented and explained the new budget and the subcommittee's reasoning behind the changes, especially utilities, periodicals, wages, and library materials. They answered questions about board member concerns.

Meredith is concerned about the low circulation and about cutting books and advertising; those areas should be funded rather than a 7% raise for the director, especially when an official review has not been done for two years.

To approve the adjusted full/part time budget for 2023 with the stipulation of evaluating the book budget in 3 months (March), with good record-keeping by Becky. If more book money is needed, Becky will ask the board for up to \$5000 for books.

# 2. Discussion/Action on Library Bylaws/Board Member Code of Conduct

Becky will fill in the blanks in the sample bylaws (including an annual meeting in May, a quorum of 3, etc.) and present them to the board for consideration as soon as reasonably possible. A vote will not be taken before the January meeting.

# 3. Discussion/Action on challenged Library materials

# It's Perfectly Normal by Robie H. Harris

Bruce and Jenny are both concerned about the content of this book and do not believe it is appropriate for children and could be used to harm them. They both think the book should not have been purchased. Meredith confirmed that Chief Hauschild said that if an adult showed it to a child, the adult could be arrested and charged with a felony. *Safe Sport* would classify this book as abuse if shown to a child. Galen and Becky S. doubt that felony charges would actually happen or be appropriate. Bruce offered that he would be dismissed as a Scout leader if he had this book around the scouts. Becky S. offered, based on her time at Embrace, that this material helps to keep children safe from abuse. Brittany added that the effect of the illustrations is similar to that of diagrams in health classes at school. She believes that the book is certainly not for everyone but should be available for children at parents' discretion.

Motion made by Bruce Seconded by Jenny To remove this book from the collection and send it back to the publisher.

Motion made by Meredith Seconded by Jenny To move this book to the adult section, preferably to a parenting resource area.

# 4. Election of Officers

Motion made by Jenny Seconded by Galen To appoint Brittany as President (to fill the vacancy left by Rick Morgan) upon her acceptance.

Motion made by Bruce Seconded by Galen To close the nomination and ask the secretary to cast a unanimous vote for Brittany to be president. Motion passed.

All other officers remain in their current roles. Officers to be elected in May at the annual meeting.

# 5. Discussion/Action on Empty Board Seats

Bruce gave an update and suggested action to be taken at the December meeting regarding a document to be given to the City and the County regarding suggestions for how to go about appointing new trustees. The document would be advisory only; the mayor with city council approval as well as the county chairperson with county board approval could choose to go about appointments in their own way.
